Helper training, evaluation and classification: Helpers will be asked to Sign the Waiver/Informed Consent and Release Form found on page 27 of the USA Helper Program. Failure to complete this form will be grounds for dismissal from the event, without refund.

For those helpers who would like to be officially evaluated and/or classified, prior to participating in a USA Helper Evaluation & Certification,

you must provide:

1. Your USA Membership card, which shows that you are a current member of USA
2. Your USA Trial Helper record book
3. The necessary documents to prove that you meet the pre-requisites for the Classification for which you desire to be evaluated. (this info begins on page 9 of the USA Helper Program document)

For the personal safety of the helper as well as liability reasons, the helper must wear protective clothing (protective pants, protective jacket, sleeve, cup and if necessary, gloves) when doing helper work during training and trials. You must bring this equipment with you and wear shoes suitable to the weather and conditions.

Please make arrangements to have a dog (or dogs) available to work during the helper seminar. There is no charge for a handler who accompanies their helper to provide a dog to be worked.

A signed waiver and entry form is required of all handlers, helpers, observers and persons present who will be providing a dog for the helpers to certify with.

WHEREAS, I, the undersigned, have voluntarily chosen to attend said event;

NOW THEREFORE, I hereby waive, release and discharge any and all claims for damages for death, personal injury, and/ or property damage which I, or my heirs, may have, or which may subsequently accrue to me or my heirs, as a result of or arising from my participation in any subject training event.

This Release and Waiver is intended to, and shall operate to, discharge in advance DDR, land owners, officers, promoters, sponsors, officials, and any other participants from and against any and all liability arising out of or connected in anyway with my participation in this event, even though that liability may arise out of negligence or carelessness on the part of any person or entity above mentioned.
